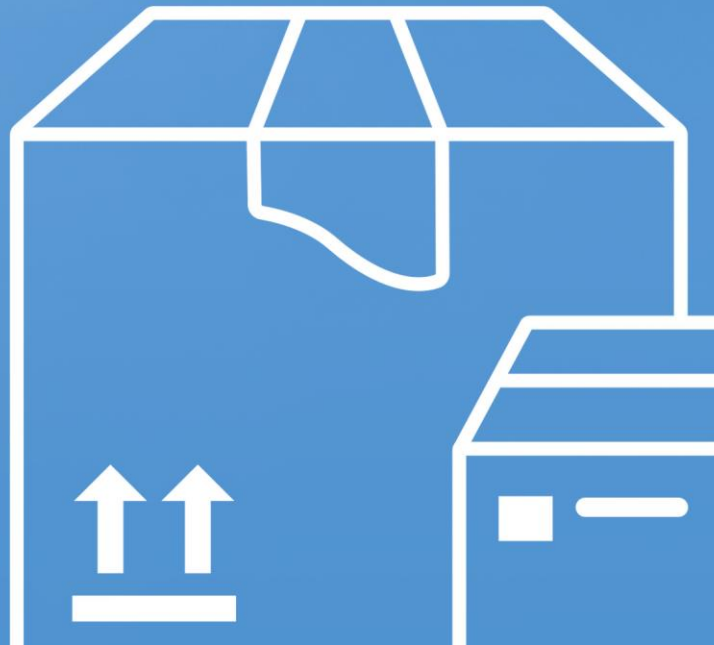

Our global network has a range of temperature-controlled facilities to maintain the freshness and shelf-life of your perishable goods. For your fruits, vegetables, seafood, flowers and other foodstuffs, you can rely on our services.

We work closely with our ground handling agents globally to closely monitor each shipment and develop our processes in line with the latest IATA standards. With Virgin Atlantic oversight at most stations across our network, your sensitive cargo is in expert hands.

For cargo where every second of temperature control counts, we work with CSafe and Envirotainer to offer a select of Active Containers to make sure the cool chain remains unbroken.

For temperature sensitive perishable shipments, full details must be provided at the time of booking, notifying us of temperature sensitivities and requesting cold storage if required. Cold storage is available on a first available basis.

Customers must ensure shipments are packed in suitable and appropriate packaging. For temperature sensitive perishable shipments, SHC codes 'COL' or 'CRT' should be clearly visible on the MAWB. Whilst temperature ranges cannot be guaranteed, we have developed special processes for perishable shipments, backed up wherever possible by specific infrastructure and trained personnel to minimise risk of spoilage.

At Virgin, we have implemented GDP certified processes to ensure your sensitive goods arrive in perfect condition. Our Pharma product offers true end-to-end compliance and assurance for you and your customers, as proven by our WDA issued by the UK's Medicines and Healthcare Regulatory Agency (MHRA).

We don't over promise or under deliver, we simply provide what you need.

At time of booking, you are required to provide full details of any temperature sensitivities and requesting temperature-controlled storage if required and a 24-hour emergency contact number. Temperature controlled storage is available on a first available basis and may not be available at every station.

You must ensure shipments are packed and labelled appropriately. SHC codes 'COL' or 'CRT' and a 24-hour emergency contact number must be clearly visible on the MAWB. Only one (1) temperature-controlled request can requested per booking.

We are approved to carry all CSafe and Envirotainer container types, and our GDP compliant processes are backed up wherever possible by specific infrastructure and trained personnel. This setup allows the goods inside the containers to travel in a constant temperature range throughout the entire journey with us.

Whilst we do not hold a stock of the containers, we can lease them on your behalf, or you can source them yourselves directly from the suppliers. All active ULDs should be delivered to us pre-screened and security cleared. For a full list of accepted containers/ destinations please visit our website or, just ask when you contact us. Active containers must be delivered to us with the relevant documentation signifying airworthiness and with sufficient battery hours or dry ice remaining for the shipment to reach its final destination. For heating/cooling containers, we will endeavour to plug them into A/C power when in situ for extended periods of time.

While in our custody and care, the containers are handled according to tailor-made processes and within manufacturers' guidelines, including the regular monitoring of temperature and battery levels. The SHC code 'ACT' should be clearly visible on the MAWB.

Rates are inclusive of fuel and security surcharges (also known as war risk), all other surcharges are excluded.

All cargo will be billed on Chargeable weight with the exception of goods on Courier – Express.

Chargeable weight is whichever is the greater of the Actual Gross Weight or the Volumetric Weight. Volumetric weight of the shipment must be calculated based on the following ratios: 6000 cubic cm per kg; 366 cubic inches per kg.

Rates are quoted in USD.

Rates are valid from the specific gateway only. Additional gateways can be found in the 'Additional in-forwarding' section and are charged according to that gateway.

Rates do not apply to restricted articles, oversized cargo, active containers, Valuable, Mail, Repatriation (human remains) and Cars. Please contact us for applicable rates.

Shipments containing Dangerous Goods (with the exception of class 9, dry ice, lithium batteries under section II and biological substances category B) will be charged an additional 40% on top of the freight rate, applied as a dangerous goods surcharge.

Dry ice is accepted on our flights where the net weight does not exceed our aircraft limitations.

The class, UN and net weight of the hazardous contents must be stated at time of booking.

DGR (dangerous goods) are accepted across select products and service levels to our direct destinations. The net weight of the hazardous content must be stated at the time of booking. Dangerous goods are accepted to our online stations and select onforwarding stations – please check with us at time of booking for any onforwarding restrictions where a trucking sector is involved.

All shipments are subject to Virgin Atlantic Airways' conditions of carriage and IATA regulations.

As per the Montreal Convention, liability shall be limited to 22 SDR's per kg and linked to the weight of the shipment, not the value. If the carrier liability is less than the claimed amount, Virgin Atlantic Cargo shall offer settlements in line with limits of liability. Any additional gestures shall be reviewed on an individual case-by-case basis.

Rates may be subject to review on shipments with excessive volume.

Shipments may be liable to a weight/volume check on acceptance and charges may be levied. Virgin Atlantic Cargo cannot be held responsible for any delays caused as a result.

Virgin Atlantic Cargo reserves the right to revise these rates without prior notification.

These rates replace all previously issued rates and are valid until further notice.

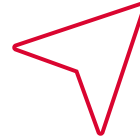

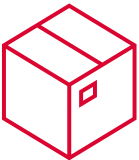
